IF YOU HAVE EXPERIENCED

SEXUAL ASSAULT, DATING VIOLENCE, DOMESTIC VIOLENCE, or STALKING,

CONSIDER THESE FIRST STEPS

Get Help

- Get to a safe place as soon as you can.
- If you believe you or anyone else is in immediate danger, call 911 as soon as possible.
- Once you are safe, contact someone you trust to be with you for support.

Get Medical Attention

- Seek medical attention as soon as possible.
- Medical attention may be necessary to mitigate the risk of sexually transmitted diseases.
- Even if you think you are physically OK, you may have injuries that need treatment.
- Forensic evidence can be collected if criminal action is desired or may be desired in the future.

Preserve Evidence and Seek Support

- Evidence may be used to provide proof of criminal activity or in obtaining a protection order.
- Evidence is best collected as soon as possible or within 120 hours of the assault.
- Medical and/or law enforcement personnel can assist with evidence collection and preservation.
- If you choose not to make a police report, consider preserving evidence in the event you change your mind at a later date.
- Seek support from campus and/or community resources.
- Remember that self-care is an important part of coping with the event.

Consider Reporting the Incident

- Contact local law enforcement.
- Report to Aquinas College's Title IX Coordinator.

Protective Measures

Aquinas College recognizes all valid orders of protection including cease and desist, nocontact orders, personal protection, or similar lawful orders. If you have a valid order, please inform the Department of Campus Safety to receive appropriate services.

Resolution Through the College

College resolution provides a prompt, fair, andimpartial investigation and resolution conducted by officials who receive annual training on issues related to domestic violence, dating violence, sexual assault, and stalking and how to conduct an investigation and hearing process that protects the safety of complainants and promotes accountability. Throughout the College resolution process, parties can be accompanied by an advisor of their choice, will receive simultaneous written notice of the outcome, have the right to appeal the outcome, and will be notified when the outcome becomes final.

Sanctions/Corrective Actions

If a respondent is found through a resolution process to have violated policy, Aquinas College may impose sanctions/ corrective actions. Sanctions may include formal reprimand, disciplinary probation, campus restrictions, no-contact order, suspension, or expulsion. For respondents who are employees, sanctions may also include termination.

Sexual assault, domestic violence, dating violence, and stalking may be found to be criminal acts, which may also subject the respondent to criminal and civil penalties under federal and state law.

AQUINAS

It is the policy of Aquinas College that no person on the basis of race, color, religion, ethnic origin, age, sex, sexual orientation, marital status, or disability shall be discriminated against, excluded from participation or employment in, or be otherwise subjected to discrimination under any program or activity for which Aquinas College is responsible. Aquinas College is required by Title IX of the Education Amendments of 1972 to ensure that none of its education programs and activities discriminate on the basis of sex/gender.
